ORDER:

In the G.O. 1st read above, orders were issued approving the establishment of the Joint Venture Company called Andhra Pradesh Urban Infrastructure Asset Management Limited (APUIAML) under the Companies Act, 2013 in collaboration with the IL&FS Group with the objective of attracting investment for financing and management of the Urban Infrastructure Projects in the State.

2. In the reference 2nd read above, Government have approved the Memorandum of Association (MoA), Articles of Association (AoA) and Shareholders Agreement as required under Companies Act 2013.

3. According to Para 5 (b) of the said G.O, Government of Andhra Pradesh in the name of Governor of Andhra Pradesh is having Shareholding of up to 49% and IL&FS is having (initially) Shareholding of 51% in the APUIAML.

4. In this regard, Government hereby nominate the Deputy Secretary (UBS) to Government, Municipal Administration & Urban Development Department as Shareholder on behalf of the Governor of Andhra Pradesh and will hold total 98,00,000/- (Ninety-eight lakh) share @ Rs.10/- each (i.e. 49% shareholding) in the APUIAML.

5. M/S IL&FS is requested to take necessary further action for incorporation and functioning of the APUIAML as per rules in force in coordination with the Municipal Administration & Urban Development Department, A.P.
