The Contractor (Security Agency) shall provide two Security Guards for vigilance at all times at the premises of Andhra Pradesh Urban Infrastructure Asset Management Limited (APUIAML), situated at 4th Floor, NTR Administrative Block, Pandit Nehru Bus Stand Arrival Block, Vijayawada, A.P., for round the clock security during the period of one-year engagement from 1.11.22 to 31.10.23. The said premises is being shared by Andhra Pradesh Inland Waterways (APIW) along with APUIAML, accordingly a tripartite agreement would be required to execute amongst APUIAML, \*APIW and the Contractor (Security Agency), as partial payment of \*Rs.20,000/- of the total bill Plus GST would be shared by APIW Overall responsibility of the Security of the APUIAML premises would be of Contractor (Security Agency) (Note: \*may vary and could be APIW or APMB)

- The above requirement shall be reviewed by the Contractor (Security Agency) and APUIAML along with APIW jointly and any suggestions for the increase or decrease of number of security guards and their working hours, shall be mutually discussed and decided as per the requirements of APUIAML. The Contractor shall provide full co-operation to APUIAML in this regard
- The Security Guards on duty will maintain the necessary registers (such as visitors & material movement register, handover & takeover register, any other registers as per statutory requirements of APUIAML & APIW) and will not allow any unauthorized person to enter the Premises at any point of time, during the Term

### **GENERAL TERMS & CONDITIONS FOR SELECTION OF THIRD-PARTY AGENCY:**

- Please do mention a fixed monthly fee (keeping in view to adhere Minimum Wages prescribed by the Government of AP) towards the above scope of work. The Fee shall include all the expenses incurred by the Contractor towards wages, ESI & PF contribution, bonus and other dues payable to the workers/personnel and government authorities to carry out all the Services. APUIAML shall not be liable to make any other payment in connection with the Security Services entrusted to the Contractor.
- as the premises has two occupants, the amount of the guards will be shared by both the companies APUIAML and APIW in the ratio given above and agreement will be done Tripartite Agreement. accordingly, please send the quote for round the clock security and charges divided by two companies, as explained above
- No extra charges will be paid if the same is not specified in the quote
