- 2.1 The Authority has adopted a Single stage with Two-Part process (hereinafter referred to as the "Selection **Process** / **RFP Process**") for selection of Agency(s), for award of the project. RFP have to be submitted hard copy in two sealed envelopes i.e., first envelope Technical Bid as Part I and in second envelope Financial Bid as Part II. The Technical Proposal to be submitted by Applicants shall comprise of technical and financial capability documents and other requisite documents/clarifications as per the terms of this RFP. The Financial Proposal, of only those Applicants whose Technical Proposal qualify the evaluation process asper terms hereof, shall be opened for further processing.
- **2.2** Applicants are encouraged to inform themselves fully about the project and other conditions before submitting their Proposals.
- **2.3** Broad description of the objectives, scope of services, deliverables and other requirements relating to this Assignment are specified in this RFP. In case, an Applicant possesses the requisite experience and capabilities required for undertaking the Assignment, it is invited to participate in the Selection Process either solely or as a consortium of entities (the "**Consortium**"), where it is to be noted that the Applicants bidding individually cannot be a member of a Consortium or vice versa.
