2.1. <u>Proposer:</u> ANDHRA PRADESH STATE CIVIL SUPPLIES CORPORATION LIMITED (APSCSCL)

Andhra Pradesh State Civil Supplies Corporation Ltd. is a State Agency appointed by the State Government for lifting of Rice and Wheat from FCI and Levy Sugar from Factories under PDS. It is the responsibility of the Corporation to undertake transportation, storage and delivery of the stocks under PDS at the door steps of the Fair Price Shop Dealers.

There are two stages of transportation of PDS commodities for reaching the stock upto the door steps of the Fair Price Shop Dealers. Transportation from FCI godowns and Sugar Factories to MLS Points is known as Stage-I transportation and transportation from MLS Points to Fair Price Shops is known as Stage-II transportation.

Marking a new chapter in the history of the Public Distribution System in the state, flagged off 9260 vehicles for door delivery of rice and other essentials to the beneficiaries. PDS vehicles, which are named Mobile Dispensing Units (MDUs) of the civil supplies department to enable door-delivery of essentials across the State.

Every MDU is equipped with GPS, for keeping track of their movements.




