#### **General Conditions for TOR**

#### I. Deduction

The client shall provide to you within prescribed time limit the appropriate tax deduction certificate evidencing payment of such taxes.

#### II. Execution of the Assignment

The agency shall keep the client informed about the progress of work.

#### III. Ownership of Copyright

Any deliverable prepared as part of this assignment shall be the intellectual property of the APUIAML. The drawings, specifications, documents and reports, survey formats, filled data sheets etc. prepared as instruments of service shall be the property of APUIAML whether the project, for which they are made, is executed or not. APUIAML shall retain copies of the agency's drawings, specifications and other documents for information and use in connection with the projects.

# IV. Arbitration
